
Institutional Review Board

INURED's Institutional Review Board (IRB) is registered with the United States Department of Health and Human Services Office for Human Research Protections (OHRP), making INURED just one of three Haiti-based institutions with the capacity to provide IRB services to researchers. The IRB committee will ensure that all proposed research meets international ethical guidelines and protects the rights and welfare of the research subjects. Additionally, INURED will be able to provide Federalwide Assurances to other organizations that require proof of compliance with human research protections. Research

INURED currently runs seven thematic Research Laboratories. The Research Laboratories are responsible for implementing research and community intervention programs aimed at priority areas of economic and social development in the country.

Each Laboratory works in partnership with a variety of national and international bodies and institutions (public and private universities, specialized research centers, the Haitian State, civi society, local communities, NGOs, international and multinational organizations, foreign ministries) and operates in close liaison with the Institute's Documentation Center and the Scientific Library, responsible for centralizing and diffusing knowledge.

Scholarship Programs

- Ten Students, Ten Dreams: provides scholarships to 10 Haitian students from Cité Soleil, a shantytown in Port-au-Prince, to study at various federal universities in Brazil. The scholarships are underwritten by the Brazilian government while INURED, an anonymous donor, and Fondation Nouvelle Haiti (FNH) underwrite the costs of scholastic materials, books and personal living expenses.
- Haiti Scholarship Program: INURED provides need-based scholarships to high performing students attending public and private higher education institutions in Haiti.
